TERMS OF USE FOR STRUCTURED OBSERVATION OF MOTOR PERFORMANCE IN INFANTS (SOMP-I)

1. GENERAL

These Terms of Use (“Terms”) govern access to and use of the web-based service Structured Observation of Motor Performance in Infants (SOMP-I) (the “Service”), provided by Movement Inspires AB, corporate registration number 559462-8264 (the “Provider”).

By ordering and/or using the Service, the organization purchasing the Service (the “Customer”) enters into a binding agreement with the Provider and accepts these Terms in full.

The Customer is responsible for ensuring that all users within the organization (“Users”) comply with these Terms.

2. THE SERVICE

The Service is a digital tool for the assessment and documentation of motor development according to the SOMP-I method.

The Service includes features such as web-based forms, visualization of results, educational materials and practice components.

The Provider reserves the right to continuously update and develop the Service.

3. LICENSE AND USE

The Customer is granted a limited, non-exclusive and non-transferable right to use the Service within its own organization.

Use is tied to the Customer’s organization. The subscription includes two concurrent licenses, meaning that up to two users may use the Service in parallel. The Customer may add up to ten (10) named users per organization.

Each user account is personal and may only be used by the individual to whom it is assigned. Login credentials must not be shared.

The Service may only be used within the Customer’s own organization and may not be used to provide services to third parties.

The Customer may not:

- distribute the Service or its content to third parties
- sell, license or sublicense the Service
- copy, modify or adapt the Service
- use the Service as part of a commercial product

The Customer is responsible for all use of the Service carried out through its user accounts.

4. USER ACCOUNTS AND SECURITY

The Customer is responsible for ensuring that:

- login credentials are handled securely
- unauthorised persons do not gain access to the Service
- any suspected unauthorised use is immediately reported to the Provider

5. PERSONAL DATA

Personal data is processed in accordance with applicable data protection legislation.

The Customer acts as the data controller for personal data processed within the Service, and the Provider acts as a data processor.

The processing is governed by a separate Data Processing Agreement (DPA), which forms an integral part of the contractual relationship.

The Service is designed so that data relating to children is processed in pseudonymized form. The Provider cannot identify individuals based on the data processed in the system.

6. FEES AND PAYMENT

Access to the Service is provided through an annual subscription in accordance with the applicable price list. The Provider reserves the right to change the price list prior to a new subscription period.

7. TERM AND TERMINATION

The subscription applies for an agreed subscription period.

The subscription must be terminated no later than thirty (30) days before the end of the current subscription period.

If termination is not made in time, the subscription will automatically renew for successive periods of one (1) year.

8. INTELLECTUAL PROPERTY RIGHTS

All intellectual property rights relating to the Service, including content, materials and methodology, belong to the Provider.

9. LIABILITY AND LIMITATION OF LIABILITY

The Service constitutes a support tool for the assessment and documentation of motor development. It does not replace professional or clinical judgment, and the User is solely responsible for interpreting results and for any decisions made based on the Service.

The Provider is not responsible for:

- how the Service is used
- interpretation of results
- decisions made based on the Service

The Provider shall not be liable for any indirect or consequential damages.

12. TERMINATION OF ACCESS

Upon termination of the subscription, the Customer's right to use the Service ceases. The Provider is entitled to suspend access to the Service after the end of the subscription period.

13. GOVERNING LAW AND DISPUTES

These Terms shall be governed by Swedish law.

Any disputes shall be resolved by Swedish general courts, with Uppsala District Court (Sweden) as the court of first instance.
